Marian University, WI is required by U.S. government regulations to check the availability of adequate funding for your tuition, fees, and living expenses for the duration of your studies. All required F-1 Visa documents must be submitted, and a \$750 USD deposit must be paid, prior to being issued your **I-20 Certificate of Eligibility**. The \$750 USD deposit is only refundable in the event that your F-1 Visa is denied. Once your I-20 is issued and your F-1 Visa is approved, the non-refundable \$750 USD deposit will be applied as payment to your first semester charges. **Prior** to arrival in the U.S., your full out of pocket costs must be paid in full, or enrolled in a 5-month payment plan. The first payment will be due on the 15th of the month in which classes start. August for a Fall start. January for a Spring start. Instructions on how to make the \$750 USD deposit, make tuition payment, and enroll in a payment plan can be found at www.marianuniversity.edu/admission-old/international-students/#app-dead.
